So since there are interested members who want to double haul, our May Casting Clinic is strictly a double haul clinic. Bring your favorite rod with a bright color floating line.

- “Down Up” to quote Mel Krieger, getting the haul right.
- How to cast 80ft of line with 4 false casts:
  - Timing your haul, got to watch that back cast too, keep it tight.
  - Shooting line, sliding it in your hauling hand, Sam's secret line grip.
  - Rod stroke vs. haul stroke, getting it all together.
- One step at a time:
  - Single Hauling, getting it right, timing, practice skills.
  - Shooting line on front & back casts, more practice skills.
  - Start with little steps then make the leap.

If you cannot make it to the free casting clinics, Sam will arrange a private lesson with a FFF Certified Casting Instructor and make a donation to FFD.

## **FROM the CONSERVATION DESK**

**BioGems Defenders join forces to stop Pebble Mine** The Natural Resources Defense Council is escalating its campaign to stop construction of the disastrous Pebble Mine in the heart of Alaska's pristine Bristol Bay watershed. A consortium of foreign mining companies, including Anglo American, has proposed a 2,000-foot-deep, two-mile-wide gold and copper mine in Bristol Bay, a true wildlife Eden that is home to the world's largest sockeye salmon streams, bears, whales, seals and eagles.

The mining giants' plan for Pebble Mine includes five colossal earthen dams to hold back an estimated 10 billion tons of mining waste, laced with toxic chemicals. NRDC is joining with Native groups, led by Nunamta Aulukestai ("Caretakers of the Land"), Alaskan fishermen, sportsmen and conservationists to protect Bristol Bay from the Pebble Mine project. BioGems Defenders contributed more than \$120,000 to run a full-page ad in the New York Times that helped generate more than 100,000 signatures on a Petition of Protest, which NRDC and Native Alaskans delivered to Anglo American's shareholders meeting in London on Earth Day.

Now they're turning the pressure up on another mega-corporation that is backing the Pebble Mine project: the Mitsubishi Corporation. We need BioGems Defenders to create a similar wave of protest leading up to Mitsubishi's shareholders meeting on June 24. Join the effort at <http://www.savebiogems.org/newsletter/index.html>.

**Water Law Decision** Napa Superior Court Judge Ray Guadagni rendered an important legal decision this month regarding water diversions. The Napa River watershed is subjected to hundred of illegal water diversions that dry up tributaries and lead to warm, slow-moving water in the summer. This, in turn, leads to poorly oxygenated water and the death of steelhead and other species in downstream water.

Grant Reynolds filed a lawsuit against the city of Calistoga, alleging it failed to protect the public trust by not complying with Fish and Game Code section 5937, which requires that the owner of any dam allow sufficient water to pass over, around, or through the dam at all times to maintain the fishery in good condition. The city responded that only the State Water Resources Control Board has the authority to sue, and that anyone who wanted to sue an agency would have to file a complaint with the SWRCB. The state board would then decide whether or not to sue. The Superior Court ruled against the city, though, deciding that anyone could file a lawsuit against an illegal diverter. This ruling applies statewide, so

that now any person who believes an illegal water diversion is killing flows can file suit against the diverter. This is a very important decision that will have wide ramifications.

**California Water Task Force** Secretary of the Interior Ken Salazar and Secretary of Commerce Gary Locke this month announced yet another task force with an aggressive interagency plan for developing a single long term integrated Biological Opinion for the California Bay-Delta and for developing near term scientific initiatives that could be incorporated into water operations as soon as the 2011 water year.

The new plan grew out of a March 19 National Academy of Sciences assessment of two separate biological opinions issued under the Endangered Species Act by the Interior Department's Fish and Wildlife Service (FWS) and the Commerce Department's National Marine Fisheries Service (NMFS). You may recall that the NAS assessment was requested by Senator Diane Feinstein. The two opinions established alternatives for reducing the effects of water management decisions on threatened and endangered species in the Bay Delta.

The two Secretaries noted that the new approach will allow for better future coordination in protecting endangered species and providing water distributions from the federal Central Valley Project and California's State Water Project.

"The plan announced today includes both near-term and longer-term strategies to ensure that we are coordinating to use state of the art science and to find the best alternatives to protect both endangered fish and water supplies," said Secretary Salazar.

"The National Academy of Sciences plan pointed to specific scientific needs to improve actions that affect water supply delivery and protect endangered species," said Secretary Locke. "We are committed to working with our state and federal partners to address these complex issues."

The goal of the near-term strategy is to incorporate new science into the process for implementing the biological opinions in water year 2011. By mid-May, an interagency task force based in the region should be established that will target those issues in the two existing biological opinions that were identified by the NAS Report as appropriate for further near-term scientific research. The task force will prepare a list of near-term actions by May 30, 2010.

Longer term, the plan calls for development of a single, integrated biological opinion based on a joint science program that encompasses Interior's FWS, U.S. Geological Survey, and Bureau of Reclamation; Commerce's NMFS; as well as state scientists. The integrated biological opinion will address the Bay Delta Conservation Plan and water project operations.

"We welcome the federal effort to create a single integrated biological opinion," said Lester Snow, California's Secretary of Natural Resources. "We are committed to working with the federal agencies to enhance our mutual goal of resolving the complex and long standing issues of the Sacramento-San Joaquin Delta."



**Final Snow Survey Results** Late season storms have brought the water content in California's statewide mountain snowpack to 143 percent of normal.

Despite the high snowpack, DWR currently estimates it will be able to deliver only 30 percent of requested State Water Project water to cities and farms in the San Francisco Bay Area, San Joaquin Valley, Central Coast and Southern California.

The 29 public agencies that purchase State Water Project water this year collectively requested 4,171,996 acre-feet of water. At 30 percent, the current allocation would deliver 1,251,601 acre-feet for approximately 25 million Californians and 750,000 acres of irrigated farmland.

Last year, the State Water Project delivered 40 percent of requests. The average allocation over the past 10 years is 68 percent of the requested amount.

**News from NCCFFF**

**NCCFFF Board Nominations** It's time for board nominations at the NCCFFF. **DFG Volunteer Program** From June 14-25 the State Department of Fish and Game will conduct training in Redding for warden assistance volunteers in the Northern Enforcement District. California's Game Warden force staff is critically thin. Add to that the reduced hours that have been imposed by tight State budgets and it is easy to see that a shortage has resulted. The snaggers, poachers and commercial abusers of our fish and wildlife resources are having a field day. DFG has a place for you if you fish, or hunt, or simply enjoy wildlife and can take the time for this training.

This is the first of these schools to be offered to Enforcement volunteers. You pay your own expenses and there is no salary at this time. The purpose of the school will be to train people that wish to help the Department support its enforcement work. The jobs they will do would otherwise take time from that required of Wardens or might otherwise go undone. DFG Director John McCamman told us at our February meeting of the NCCFFF that other schools for volunteers are planned for later dates in different parts of the state.

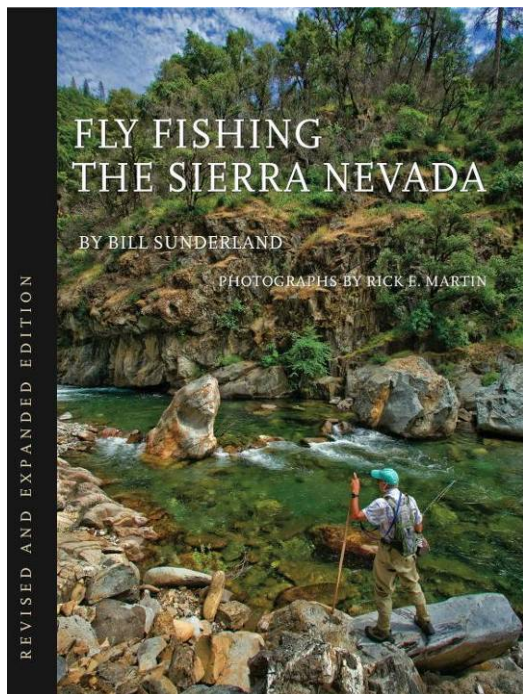

## Fly Fishing Book of the Month

### *Fly Fishing the Sierra Nevada* By Bill Sunderland - Photos By Rick Martin Revised and Expanded Edition-2008



Many of us are familiar with Bill and his works and talks. If you have been to FFD meetings where Rick Martin has been our guest speaker then you are familiar with him. The two of them put together this new and revised edition of Bill's *Fly Fishing the Sierra Nevada* and it is a good book to review now that the spring season is under way. The information is extremely useful and the photographs are a delight.

Bill starts this book with an introduction, writes about the Sierra Nevada Range itself, and then moves through the range and gets us into places to fish. He writes "The recorded history of the Sierra Nevada began on April 2, 1772, when a Catholic missionary, Pedro Font, saw the mountains at a distance from the San Joaquin Valley. He described them in his diary as "una grand sierra nevada," which translates from the Spanish as "a great snowy range." This year's snow fall and continuing rain/snow sure proves the Padre correct.

Bill gets into things out there that will hurt or try to kill you (giardia, rattlesnakes, and such). Does a bit on bugs and then moves the reader across the Sierra Nevada Range and talks about fishing. The book is broken down into three areas of the Sierra Nevada's: Northern, Central, and Southern waters. The book covers a great many rivers, streams and lakes where if you are looking to go for the first time or just wanting to read up on your favorite fishing stream it will give you a fresh insight. Between Bill's writing and Rick's photos, this cool book will keep you entertained and might get you onto the water sooner than you had planned. It is a great book with wonderful photography, maps and descriptions of fishing in

our own Sierra Nevada Mountains.

I will be taking a few months off during this summer from the column to go fishing. So, there won't be any book suggestions from me until September, but that does not mean you can't find some favorite fishing books on your own. If anyone wants to write a review, please do so and send it off to our newsletter editor Brian. Have a GREAT fishing summer!

## Pyramid – Just a Little Breeze

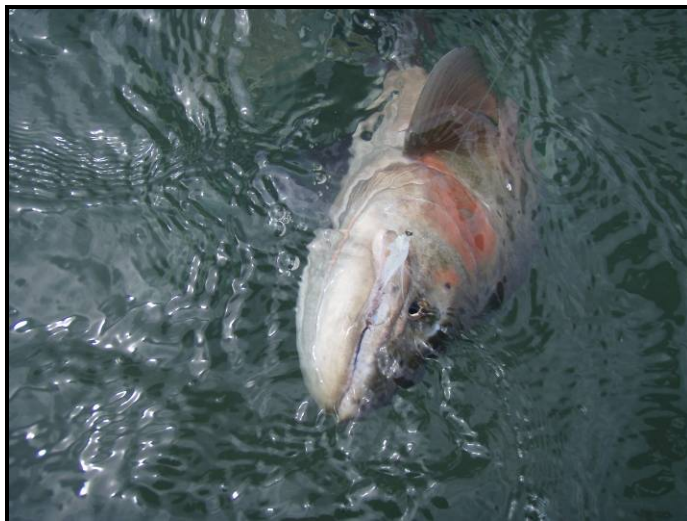

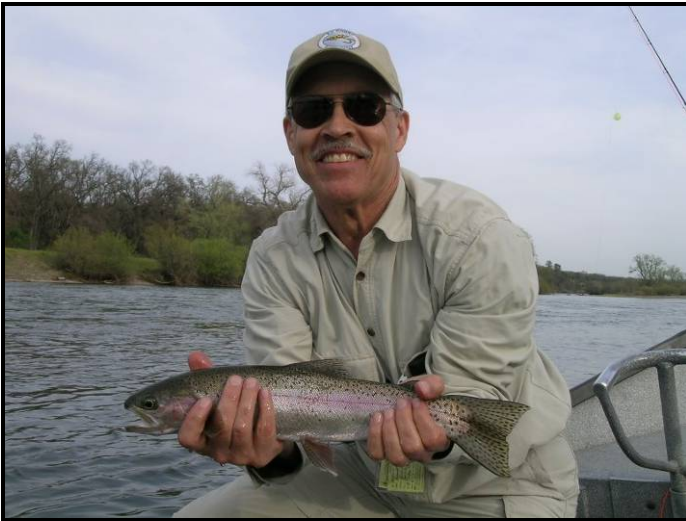
