**Lance and Kirsten Gray Present:**

***“Steelheading on the Feather”***



At the September 27 meeting of the Fly Fishers of Davis Lance and Kirsten Gray will present “Steelheading on the Feather”. The presentation covers history, angling information, access points, fly-fishing techniques and flies. Lance will also demonstrate setting up rods and tying flies in a hands-on setting if time allows, and will provide handouts on the presentation.

The Feather River is one of California's best-kept secrets – it's an awesome steelhead fishery. This tail-water fishery begins below the Oroville Dam and holds both hatchery-bred and wild fish. This stretch of the river is called the Low Flow section and the fishing can be fantastic. Hooking six or more fish on a trip is not uncommon and steelies in the 10-pound range are possible.

Lance and Kirsten Gray have more than 50 years combined experience in fly fishing. Lance started fly fishing with his father

and brother Lincoln at age 7. In his teens, he began tying flies commercially for shops all around Northern California. At 17, he went to work at Powell's in Chico, working in the fly shop and building rods. He guided for Powell's, conducted fly-tying and fly-fishing schools, and traveled. In 2003, Lance and Kirsten launched Lance Gray & Company, a full-service outfitter offering guided trips, fly-fishing schools, workshops and a travel agency. Lance conducts presentations at fly clubs and outdoor shows and supports local groups like Cub Scouts and 4H. Kirsten is a fantastic photographer who's had images published in periodicals and on websites.

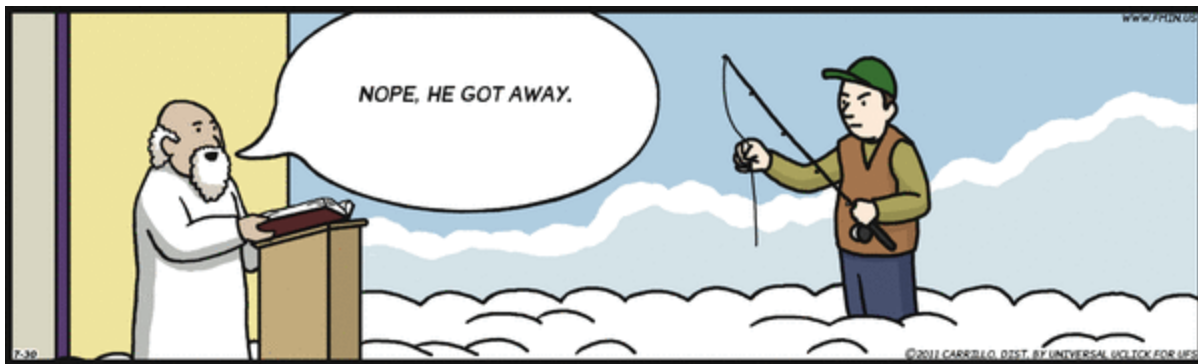
**Don't forget the picnic!**



## **CONSERVATION UPDATE**

**Area of Origin Lawsuit** Federal Court Judge Oliver Wanger ruled last month that the Tehama-Colusa Canal Authority does not have area-of-origin water rights over federal water contractors in the San Joaquin Valley.

California Water Code 11460 states that in an "area wherein water originates, or an area immediately adjacent thereto which can conveniently be supplied with water," the area "shall not be deprived by the department directly or indirectly of the prior right to all of the water reasonably required ..." for beneficial needs.

The Central Valley Project is federally operated by the Bureau of Reclamation. There are rules that require the federal government to follow state law, but in this case Judge Wanger ruled against Tehama-Colusa.

According to this ruling, the TCCA must apply for a separate water right permit from the State Water Resources Control Board; it does not have a right to preferential allocation of CVP water.

**Judge Wanger to retire** Judge Oliver W. Wanger is taking the rare step of leaving the bench and returning to private practice. His last day at Fresno's federal courthouse is Sept. 30, a Friday. The following Monday, he'll hang out his shingle as a partner at the newly created firm of Wanger Jones Helsley.

Wanger said he's frustrated by the Fresno court's growing caseload and Congress's unwillingness to add judges here.

Wanger has been the main judge overseeing the ongoing Sacramento-San Joaquin Delta water wars between farmers and other water users and environmentalists. In the middle are the delta smelt and endangered salmon – as well as reams of complicated state and federal water law.

**Massive fish kill at the pumps** Dan Bacher reported earlier this month that a mind-boggling 11 million fish have been "salvaged" at the export pumps since January 1. "Salvaged" pretty much means "killed," since the majority of many species perish during and after the salvage process, including handling and trucking operations.

The losses include close to 9 million Sacramento splittail, the largest number ever recorded. Department of Fish and Game staff recorded a total of 46 species "salvaged", including threadfin and American shad, striped bass and largemouth bass, white catfish, Chinook salmon, steelhead, smelt, bluegill, and sturgeon.

Bacher cites "A Review of Delta Fish Population Losses from Pumping Operations in the Sacramento-San Joaquin River Delta," prepared by Larry Walker Associates in January 2010 for the Sacramento Regional County Sanitation District. According to that report, salvage statistics "greatly understate the total number of fish entrained, since they do not include the number of fish lost to predators or lost through the fish screens. In fact, recent estimates indicate that 5-10 times more fish are lost than are salvaged, largely due to the high predation losses in and around water project facilities."

Meanwhile, Delta water exports are heading for an all-time high in 2011.

**Suit filed to halt water contracts** CSPA, Friends of the River, North Coast River Alliance, Save the American River and the Winnemen Wintu Tribes have filed a lawsuit against Westlands Water District (and its two water distribution districts) and the U.S. Bureau of Reclamation, as a Real Party in Interest, over the renewal of six interim Central Valley Project (CVP) water service contracts. The action, filed 25 August 2011, concerns six contracts providing up to over one million acre feet of water annually from the Delta.

CVP water exports are a principal reason for the decline of Delta fisheries.

Westlands, et al. claims the contracts are exempt from the California Environmental Quality Act. The coalition disagrees and is asking to have the contracts declared unlawful.



## **NCCFFF Report**

#### **The Festival of Fly Fishing (Conclave) is back!**

Mark your calendars for the weekend of ***October 7-9, 2011!*** This year, the Northern California Council is staging a full-blown Conclave! The event will be held at the Nugget Hotel and Casino in Sparks, Nevada. It looks to be a fine venue, and the timing couldn't be better, fishing wise! That's prime time in the Sierra, and there are plenty of great waters nearby to fish—Pyramid Lake in Nevada, The Truckee River in both California and Nevada, the Little Truckee, Davis and Frenchmen's Lakes to name only a few.

There are discounted rates for those wishing to stay at the Nugget, and plenty of other accommodations in the area.

The Conclave will consist of continuous casting and fly tying demonstrations on Friday and Saturday (where you can watch top California tyers tie), take classes and catch lectures on various aspects of fly fishing. A strong turnout of Fly Fishing manufacturers and retailers exhibiting the newest fly fishing gear is expected.

There is a Friday night cocktail get-together, and Saturday is the main event, with tying and casting continuing, plus the dinner and a big raffle in the evening. On Sunday, there will be on-stream/lake classes for all levels of fly fishers.

#### **Vets fishing Program** *by Ken Brunskill and Marty Seldon*

A key tool for the VFFF fly tying program is the Evergreen Hand. It is a device where a fly can be tied with one hand. The tool essentially becomes the hand holding the material. It was initiated by a group of FFF folks in the Evergreen Fly club in the Washington State area and has been a work in progress ever since, with many variations and additions being added all the time. Building on the initial development in Washington State, Mission Peak Fly Anglers and Ken Brunskill developed numerous tools for distribution through the VFFF Facebook page. VFFF has the distinction of conducting fly fishing oriented workshops in one of the largest VA regions in the country, the

Veterans Administration's Palo Alto Health Care System (VAPAHCS). Fortunately the program enjoys enthusiastic support from their recreational therapy department. VAPAHCS is a leader in the mental health care of our veterans, and together with VFFF they have witnessed positive change in the participating veterans. Extremely rewarding!

Volunteers from five NCCFFF clubs are conducting regular VFFF fly fishing workshops in four different locations. The clubs are: Mission Peak Fly Anglers, Diablo Valley Fly Fishers, Peninsula Fly Fishers, Tri Valley Fly Fishers and Tracy Fly Fishers.

In early June VFFF conducted three terrific outings where 12-25 veterans of all abilities were able to go fishing. Plans are currently underway to start the first disabled veterans FFF charter fly fishing club at the Veterans Administration's Menlo Park facility. Since many disabled vets automatically receive FFF membership, it should be simple, and is on track. Once details such as articles, by laws, and approval by the FFF and the VA are completed, the new Veterans and Mentors Fly Fishing Club should become a reality. We hope that VA and FFF approvals come soon, and that this club will be the first of many fly fishing clubs, by veterans, for veterans.

The VFFF Committee members designed a unique fly as their club logo and Gene Kaczmarek tied a beautiful specimen. Each part of the fly has special significance to all Americans and especially to veterans.

**Editor's note:** The Fly Fishers of Davis conducted a very large event for the Palo Alto/Menlo Park VA hospital on June 19, 2009 in Vacaville's Pleasants Valley. We hosted 34 veterans from Desert Shield to Iraq and Afghan veterans, and one injured dog. They fished all day and we fed them some 80 hamburgers and 60 hot dogs at a large picnic. The event was one the largest in northern CA at its time, and was very rewarding for the many FFD members who attended. Thanks again to John Imsdahl, whose tireless efforts were required to get all parties together on this event!

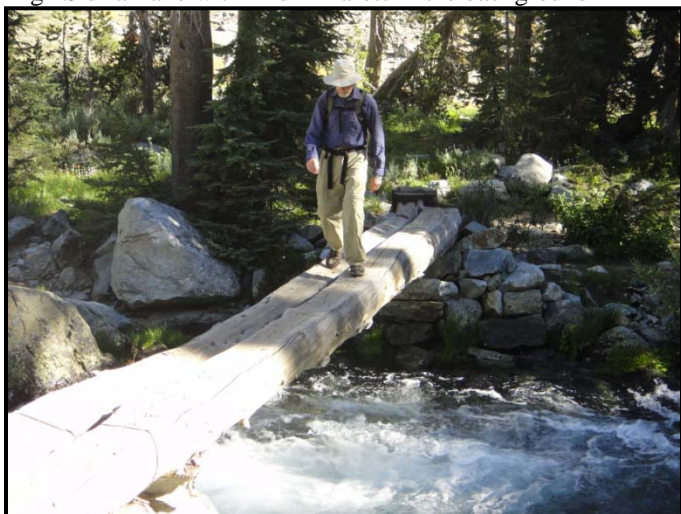

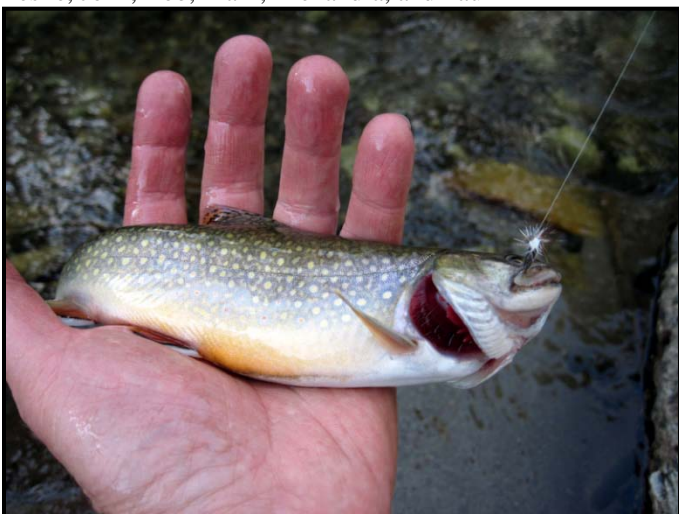

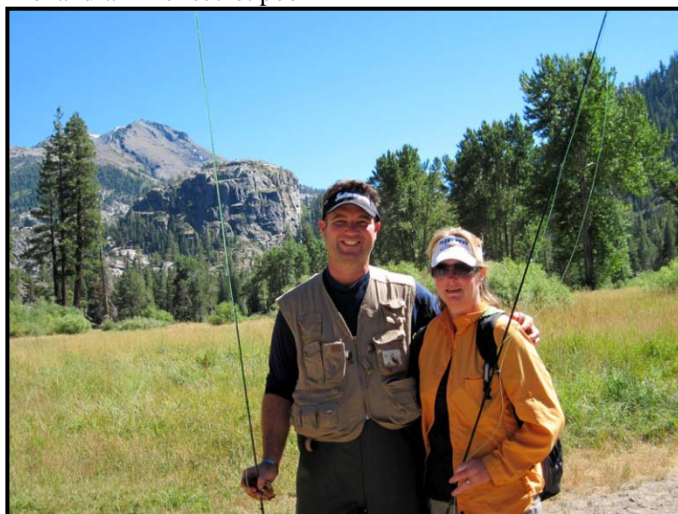

## Book of the Month

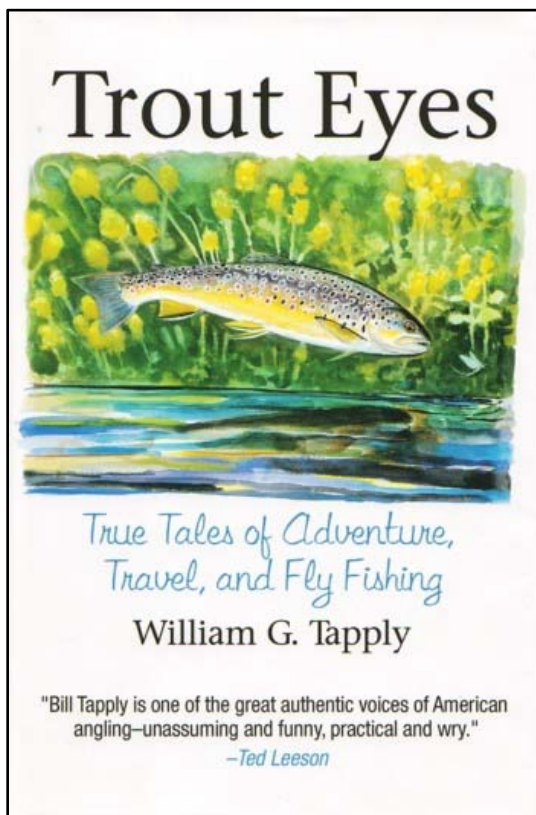
### “Trout Eyes”

### *True Tales of Adventure, Travel, and Fly Fishing*

By William G. Tapply

The book is broken into 28 chapters in 5 different parts covering trout, salt, gear, travel, and random musings. The chapters are all quite short, often lasting no more than 10 pages due to their magazine origins. Within each chapter Mr. Tapply generally begins with a thought or event, and then digresses to a memory of another time, often with his equally famous father HG Tapply. Tapply's writing is filled with the same kind of kind-hearted humor, interesting tips, and personal idiosyncrasies that we often enjoy as fly fisherman.

I could not help, while reading this book, to compare the style of writing to John Gierach. While Gierach is part philosopher-part angler, Mr.



Tapply has a sort of home-spun story-telling style much like you would expect sitting at a campfire after a hard day on the river with your fly fishing friends. His many digressions to memories of his father (who at the time of this publishing had passed away five years previous, sadly Bill Tapply also passed away in 2009) forces us to reminisce of our own time in the outdoors with our fathers, grandfathers and friends.

Reading *Trout Eyes* was like sitting down with a good friend and talking about all the good trips from times past, the weird things you read about in Such-and-Such magazines, and having a few laughs, over beers, about things we all have done from time to time.
