





Ken Lazzaroni Mark Sanders



FFD Beginning Fly Tying Class By Kieth Barton



The pipedream shared by most fly fishermen is tying flies is cheaper than buying them. The truth of the matter is that while fly tying does provide angling entertainment similar to fishing – especially when inclement weather is howling outside – the real truism is that you'll feed more moths than fish ... but will be the toast of all your friends ... as they help themselves to the contents of your fly box.

The Davis Fly Fishers will be hosting their annual Beginning Fly Tying class at the UC Davis Viticulture department lab starting next month. The course will cover a dozen different patterns (six dry and six wet) and will host discussions on materials, fishing anecdotes (mostly exaggerated), will task your dexterity and "small finger skills", likely to lead to much swearing and great frustration.

The dates for the class will be **January 3, 10, 17, 24, 31 and February 7**. Each class will start at 7:00PM and extend until 9:00PM, instructors will be there a bit earlier to set up the AV gear, so there is ample opportunity to engage in additional discussion prior to the class start. The course will cost \$15 (collected at the first session). Typically class sizes are small, and talented instructors outnumber students, so this is an opportunity to get quality assistance in an intimate setting.

No tools or materials will be needed by prospective attendees, we'll have extra vises, bobbins, and scissors for those that lack the basic tools.

CONSERVATION REPORT

Trinity River Alert! Last month we heard a program about the Trinity River Restoration Program (TRRP) and how it aims to improve the river below Lewiston Dam for anadromous steelhead and salmon. Last week the Department of Interior disbanded the Trinity Adaptive Management Working Group (TAMWG), a stakeholder oversight group made up of environmentalists, utility interests, landowners, raft guides, and business interests. The group was formed along with the TRRP in the 2000 Record of Decision on the Trinity with the aim of restoring fisheries on the river that have been impacted by the dams, water diversion to the Central Valley, and historic mining and logging operations. The TAMWG provides citizens' advice and oversees the activities of the Trinity Management Council, which manages the TRRP. The DOI's rationale for disbanding the group is that the TAMWG did not submit a short justification memo to continue their operation.

The group's leader, Tom Stokely, said the group was never asked to provide such a memo, but they would have done so had they been asked. He also said the U.S. Fish and Wildlife Service, which acts as a liaison between the TAMWG and DOI, submitted substantial paperwork in an attempt to get approval for TAMWG meetings in June, July, September, and December.

The TAMWG has no meeting scheduled between now and January 1, and the members' appointments expire in January, making the group effectively disbanded.

TAMWG members were shocked at the news. Several expressed the opinion that their oversight had led to productive changes in how the river was managed. We heard at our meeting how the TRRP uses adaptive management to refine its work; this loss of citizen oversight is a blow to the adaptive management program.

There is a chance the Interior Department will agree to extend the service of the TAMWG, but it will take some

effort on our part. CalTrout and other groups are writing letters to Interior Secretary Ryan Zinke. You can help. Send an email or mail a letter to Secretary Zinke.

Here's a sample letter – if you edit it to make it your own it will have more effect. For example, add why the Trinity River is important to you, and why you want to see citizens' oversight continue. You could mention that you recently heard a presentation about the TRRP and what it meant to you.

Dear Secretary Zinke,

I disagree with the recent decision to deactivate the Trinity Adaptive Management Working Group (TAMWG), a primary component of the Trinity River Restoration Program. TAMWG is comprised of volunteers, a diverse group of stakeholders that provides valuable input to the Trinity Management Council. Taking away their input is taking away the public's crucial opportunity to be closely involved in decisions affecting the Trinity River. Without the working group, stakeholder engagement will be limited to only the public comment period during Trinity Management Council meetings, which will not satisfy the public's capacity to provide input.

I encourage the Department of the Interior to immediately re-instate the Trinity Adaptive Management Working Group.

California's Native Trout, Salmon, and Steelhead in Peril

Fish and watershed advocacy group California Trout (CalTrout) and University of California Davis, Center for Watershed Sciences recently released key results from an in-depth report detailing the status of 32 types of salmon, steelhead, and trout that are native to California. The report entitled "State of the Salmonids II: Fish in Hot Water" (SOS II) paints a grim picture of the future of our state's native salmonids: if present trends continue, up to 45 percent of these native species will likely be extinct in 50 years. The study is a completely updated edition of the first version of this report produced in 2008. Due to the drought and the increasing effects of climate change, the scientific findings in SOS II show that conditions are much more dire for our salmonids: 81 percent of these species are worse off today than they were less than a decade ago.

The report includes an analysis of key threats to the survival of each species, starting with the overarching threat of climate change, which is likely to reduce the availability of cold water habitat that salmon, steelhead, and trout all depend on for survival. It also highlights various human-induced threats such as dams, agriculture, estuary alteration, urbanization, and transportation.

The loss of these iconic fish would be an epic tragedy. Native to California and uniquely adapted to our diverse landscape, they are more than just resident fish. By flourishing they signify that California's legacy of cold, clean water has been preserved, an asset as vital to our state as epic coastlines, magnificent Sierra Nevada range, towering redwoods and beautiful deserts.

The SOS II report not only tells the story of the fish. Its findings lay out a clear set of actions and a path forward. To reverse the trend toward extinction, the report suggests prioritizing protection and restoration efforts in three general areas:

- 1. **Protecting the most productive river ecosystems** remaining in California, such as the Smith and Eel Rivers, must be a priority. These strongholds, among others, have the capacity to support diversity and abundance because they retain high quality habitat and are not heavily influenced by hatcheries, supporting the persistence of wild fish.
- 2. Increasing **focus on source waters will keep more water in streams** and reduce stress on fish during drought, buffering the effects of climate change. Sierra meadow restoration, springs protection, and progressive groundwater management all contribute to this effort.
- 3. **Restoring function** to once productive but now highly altered habitats can greatly improve rearing conditions for juvenile fish, especially floodplains, coastal lagoons, estuaries, and spring-fed rivers.

CalTrout has devised an action plan to return our rivers and salmon, steelhead, and trout back to resilience, and it starts with implementing on-the-ground conservation projects in key geographical areas where wild fish influence the community. CalTrout is leading projects such as:

- Barrier removal from Eel River tributaries, opening up miles of quality habitat for steelhead and salmon.
- Working with ranchers in Shasta and Scott Rivers to improving irrigation methods and leave more cold water instream for endangered salmon.
- Advocating for water infrastructure investments in the Central Valley to improve floodplain management for fish and people.
- Reconnecting fragmented habitat in Orange and Ventura counties **benefiting endangered Southern** steelhead.
- Meadow restoration in the Sierra Nevada to improve snowmelt holding capacity, **improving habitat for fish such as the California Golden trout.**

These projects will take years. CalTrout is in it for long haul, ready to scale up and do more. The science-based SOS II report is clear: If we don't act, we risk losing our native fish species to extinction.

Fly club members can take action to support these efforts. Consider becoming a CalTrout donor and contribute to their mission ensuring resilient wild fish in healthy waters for a better California.

Our fisheries face mounting threats, and it is up to each of us as Californians and fly fishers to stay informed and support efforts to protect the species we love to pursue in California.
