Brent Hublitz Presents: "Fly Fishing The Klamath River Basin"**

This month, Tuesday May 29th at Harper Junior High School, the Fly Fishers of Davis will hear from Brent Hublitz who will discuss the Klamath River Basin Redband Trout and the techniques to catch and release these very wary fish. Agency Lake and Upper Klamath Lake have a large population of native Redband Rainbow Trout that would appeal to any lake angler. Early spring and fall can be exciting times to focus on these native fish. During this time the fish are packing on weight, either preparing for or ending a long winter. There are many feeder streams such as Crystal Creek, Odessa Creek and Recreation Creek that these fish frequent from spring until fall. Believe me, it's a blast stalking wild mammoth fish in these crystal clear, spring fed waters.

Brent Hublitz is a 23 year Veteran of the United States Air Force and Army who has been fly fishing his entire life. He's been guiding the Klamath Basin



going on 15 years as owner and operator of Trophy Troutfitters. He knows where to find the fish, and has the patterns and techniques to catch some of the most elusive trout of the Klamath Basin. He specializes in Southern Oregon guided fly fishing adventures on the Wood River, Williamson River, Rouge River, Sprague River, and the most demanding lakes you will find in your fishing career.

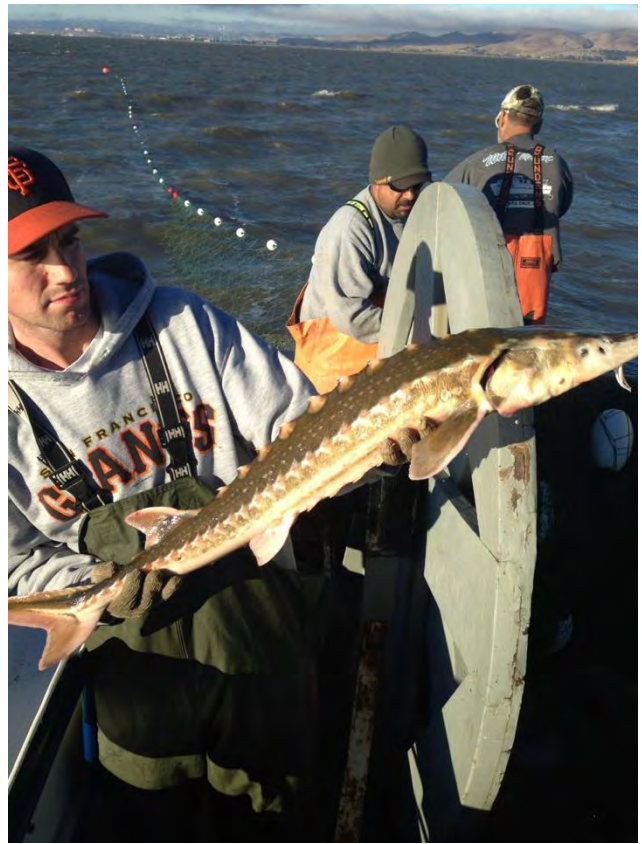
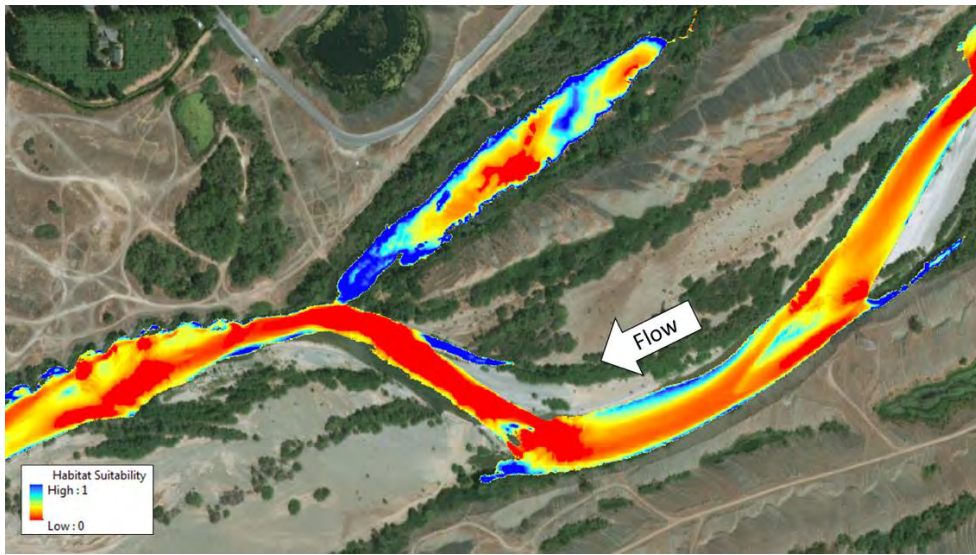

FFD OUTREACH: 2018 FFD UCD Center For Aquatic Biology and Aquaculture Scholarship Recipient: Pete Moniz

My name is Pete Moniz and I am a first year Master's student in the Hydrologic Sciences Graduate Group at UC Davis. I was born and raised in California's Central Valley, and like many others from this area, my family escaped the Central Valley's summer heat by spending our vacations up in the Sierra Nevada mountains camping and fishing at its many lakes and rivers. I received my Bachelor's degree in Environmental Sciences from UC Berkeley in 2013. After graduating, I worked with the California Department of Fish and Wildlife monitoring fish species throughout the Sacramento-San Joaquin River Delta. Knowing that I was most interested in salmon and trout ecology, I then joined Cramer Fish Sciences in 2014 where I got to work on salmon and trout adult spawning and juvenile rearing habitat restoration projects on many of California's rivers, including the Yuba, American, Mokelumne, Stanislaus, Merced, and San Joaquin Rivers.

As a graduate student here at UC Davis, I am currently working with Professor Greg Pasternack on a thesis project aimed to analyze the quantity and quality of available habitat for juvenile Chinook salmon and rainbow/steelhead trout on the lower Yuba River. The lower Yuba River still supports a population of resident rainbow trout and yearly returning Chinook salmon and steelhead trout, but like nearly all rivers in California, decades of human impacts have severely degraded the river's available habitat from what it once was. I will use digital maps of water depth and velocity created from one of the most sophisticated hydraulic model programs available along with digital maps of cover habitat (e.g. vegetation and large substrate) to identify and quantify high quality habitat patches along the river. With this data, I will create a physical habitat model that shows if and how high quality rearing habitat changes with changing discharges over time. The results of this research will help aid dam operators and resource agencies in making location-specific, cost-effective, and scientifically sound management decisions regarding exactly when, where, and how to conserve and restore salmon and trout habitat on the lower Yuba River. With increased high quality habitat comes an increased chance of these juveniles surviving to adulthood and someday being appreciated by some lucky angler in California.

CONSERVATION REPORT

California Rivers Day On May 9 I participated in California Rivers Day at the state Capitol. This is an annual event sponsored by Friends of the River to advocate for river-friendly legislation. This year we had had over 40 participants to advocate for two bills. AB 2975 is carried by Assemblymember Laura Friedman, and would protect California's Wild and Scenic Rivers. California now has more than 2,145 miles of rivers protected in the federal or state Wild and Scenic River systems. Of those, 747 miles are protected only under the federal system. AB 2975 would apply only to those 747 miles of river. If the federal government takes action to delist a river from the federal system, it would authorize the Secretary of the California Natural Resources Agency to hold a public hearing, add the threatened river or river segment to the state Wild and Scenic Rivers system, and classify the appropriate segments as wild, scenic, and recreational. It would not add any new rivers to the state system, but would protect rivers currently under federal protection that are not in the state system.

The second piece of legislation is alive in both the state Senate (as SB 606) and the Assembly (as AB 1668). The state requires a 20% reduction in urban water use by 2020, but currently has no measures in place to track or encourage reductions. This legislation would establish standards for efficient water use and require urban water suppliers to set long-term water use targets/budgets that account for regional variations. It would also strengthen drought planning by putting standardized planning and reporting practices in place with support for small and rural communities. Finally, it would improve agricultural water management practices, planning, and reporting by requiring plans to be filed and made public with water budgets and evaluation of how they can improve soil health through on-farm practices. Currently, only 40% of agricultural water suppliers submit their water management plans on time and less than 15% of them have submitted them annually. This legislation is an important part of dedicating water for conservation purposes.

A side benefit of visiting legislators is that I found out Senator Bill Dodd is a fly fisher. I invited him to come to one of our meetings, so don't be surprised if he comes to our picnic or a regular meeting later this year.

If you'd like to get involved in this way next year, please let me know. Friends of the River does this event annually, and it's really fun and interesting.

Tunnels lawsuits could be outlawed Rep. Ken Calvert of Riverside County released a 142-page draft spending bill for fiscal year 2019 for the Interior Department and related agencies. Tucked into the bill is a brief provision that would prohibit state or federal lawsuits against "the Final Environmental Impact Report/Final Environmental Impact Statement for the Bay Delta Conservation Plan/California Water Fix ... and any resulting agency decision, record of decision, or similar determination." In other words, no one with concerns about environmental damages the Twin Tunnels might cause could be heard in court. If you agree that this rider would circumvent due process and state rights you might want to contact your representatives in congress, especially Senators Feinstein and Harris, and let them know.

Tunnels Funding The Santa Clara Valley Water District reversed its earlier vote (to support a single tunnel only) last month and voted 4-3 to commit up to \$650 million to support the Twin Tunnels, aka California WaterFix. The vote was delayed for three days after numerous people objected to the change, but the district ultimately went ahead with the funding.

In other news Last week the California Department of Water Resources entered into a Joint Exercise of Powers Agreement with the Delta Conveyance Design and Construction Authority (DCA), forming a partnership for the design and construction of California WaterFix.

"This agreement signals a key step toward implementation of WaterFix, and this partnership represents a true collaboration in the best interests of California," said DWR Director Karla Nemeth. "We look forward to working with the DCA to finalize permitting and design, and to safely and efficiently build WaterFix." The DCA is a public agency composed of local public water agencies who are investing in California WaterFix, otherwise known as the Twin Tunnels.

According to DWR the DCA will pool the expertise and resources available from DWR, public water agencies, and consultants to design, construct and deliver the project.

DWR will oversee the work of the DCA, and will own and operate the project as part of the State Water Project once construction is complete.

Delta Counties respond The Delta Counties Coalition offered public comment in response to the formation of the new Delta Conveyance Design and Construction Joint Powers Authority at its board meeting today.

The DCC is an alliance of the counties of Contra Costa, Sacramento, San Joaquin, Solano and Yolo. The DCC advocates for protecting the interests of the Delta and California's water supply and has produced a set of approaches that will achieve balance for the economic and environmental health of the Delta while also improving water supply stability. Contra Costa County Supervisor Diane Burgis stated, "Some have called the WaterFix a diabolical plan, bold, and presumptuous. The Delta is a special and unique place. Those of us who are directly impacted are being locked out."

San Joaquin County Supervisor Chuck Winn stated, "We have the opportunity to build a world class water system, but instead we are getting a flawed, inadequate, and enormously expensive project that will not benefit the residents of California."

Yolo County Supervisor Oscar Villegas remarked "There is a finite capacity to generate ratepayer dollars for investment in water system improvements and WaterFix will effectively squeeze out the ability to invest in more beneficial and cost-effective projects."

Solano County Supervisor Skip Thomson said, "Expediting the project with a JPA at this point in time is grossly inappropriate. Where it may make the Governor happy, it is bad public policy to acquire land, design, and construct the proposed project before it is fully permitted and before environmental impacts identified. In addition,

many lawsuits are pending and bonds have not been validated."



Klamath Coho get water Last month I noted that irrigators in the Klamath River Basin asked for a reprieve from a court decision that set aside 50,000 acre-feet of water to be used to increase Klamath River flows to protect threatened Coho salmon from disease outbreak. They argued that drought conditions in the basin this year threaten their livelihoods so the water should be used instead for irrigation. This month U.S. District Court Judge William H. Orrick denied their request.

A court injunction requires the Bureau of Reclamation to hold 50,000 acre-feet of stored water in Upper Klamath Lake through early June to flush away a deadly parasite that infects threatened coho salmon.

Because it's been a dry year, the bureau believes the injunction makes it unlikely there will be enough water for farms.

The ruling pleased groups that rely on salmon, such as the Yurok Tribe and Pacific Coast fishermen. But environmental and local groups are worried that the ruling could lead to further turmoil, such as what happened in 2001 when farmers illegally opened the irrigation gates and 68,000 salmon subsequently died of disease.

Others are worried that extremists could use this as an excuse to foment discord and bring attention to anti-government causes.



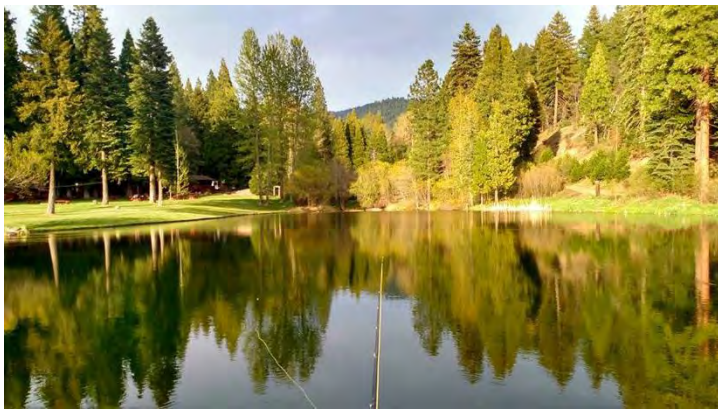
