## Conservation News from NCCFFF

**CHALLENGE TO SUCTION DREDGING PERMIT PROCESS -** Over the past several years,

the Council has been concerned about the impact of suction dredging on rivers and fish. Dave Ford and Norm Stevenson have previously represented NCCFFF in extensive dialogue with interested parties including the Department of Fish and Game (DFG), the permitting agency. Unfortunately, meaningful reform of the permit process has not occurred. The importance of this issue has increased with the ESA listings of steelhead and salmon in some of the rivers where dredging occurs. With the support of Friends of the River and the environmental Law Foundation, the Council recently signed on to a letter to DFG announce intent to file a legal challenge to the suction dredge permitting process. We await DFG's response to this letter. The DFG has routinely issued permits for suction dredging without following provisions of law. For example, the law states that a permit is to be issued only if DFG determines ".... the operation will not be deleterious to fish" Despite this clear condition, permits have been routinely issued even though the application form asks only for personal information about the applicant. Further, the law requires DFG to determine on every application whether "an onsite investigation of the project" is "deemed necessary by the department." This is obviously impossible if DFG doesn't even know where the dredging will occur. Of course monitoring and enforcement is virtually non-existent. There's more, but you get the idea.

**LOWER YUBA RIVER UPDATE -** Under the "energy crisis" banner, the State Water Resources Control Board (SWRCB) bowed to the interests of water diverters and issued a revised flow decision for the Lower Yuba which is totally inadequate to support the fishery. NCCFFF was among several conservation groups filing motions for reconsideration. We expect the motions will be denied. Informal meetings are taking place among various interests, but the progress to date has not been encouraging. Pending the course of these discussions, a coalition of groups including NCCFFF, is currently evaluating further options, including a potentially costly legal challenge. Thanks to Bob Baiocchi, Mike Fitzwater, and Nathan Joyner who have been representing the council on this issue.

### **RESPONSE TO CALAVERAS COMPLAINT -**

In the spring of 2000, NCCFFF joined CSPA in filing a complaint with the State Water Resources Control Board to protest a fish kill, including ESA listed steelhead, which resulted from severe flow fluctuations on the outflow of New Hogan Dam on the Calaveras . The good news is that as a result of our complaint, the dam operators will have to consult with National Marine Fisheries Service (NMFS) to insure that steelhead are not harmed by operation of the dam. SWRCB deferred action stating they lacked adequate information, due in part to the fact that they never received the information they requested from DFG. DFG's lack of response was particularly disconcerting since the kill involved ESA listed species, and DFG staff led the research to prove the dead fish were steelhead. Bob Baiocchi sent a strong letter to DFG on behalf of the Council requesting an explanation for their inaction, also requesting a prompt and thorough response to SWRCB request. We received an encouraging reply from DFG which now commits them to consult with their steelhead experts and to submit the requested information to SWRCB. We hope this information will lead to action by the Board itself.

**PIT RIVER FERC LICENSE UPDATE -** The conditions defined in the renewed Pit license will affect this river for decades. PG&E has filed a draft license application with FERC, and the Pit River Collaborative Team is now meeting two days each month. The importance of these meetings will continue to increase over the coming months. Thanks to Alan Ulrey of the Shasta Fly Fishers who has attended Northern California meetings of the Pit River Collaborative Team on behalf of the Council.

A consultant was recently engaged to assist with facilitating the process which should be a plus in the long run since a clear process has now been defined for the Collaborative Team to follow. It now appears that PG&E wants to reach a settlement with stakeholders. Earlier in the process, PGE indicated they would be using the "traditional process", but would hold meetings with a collaborative team to get input. 

## **FLY PATTERN OF THE MONTH Yellow Stimulator**

The Yellow Stimulator was originated by Randall Kaufmann. It can be used as an imitation of the little yellow stonefly, or as a general attractor or searching pattern. There are a number of color variations in the stimulator series including olive, green, royal and orange in addition to the yellow. There are some version with rubber legs attached to the thorax.

#### **Yellow Stimulatory**

Hook: Tiemco 200 R in sizes ranging from 6 to 16.

**Thread:** Orange for head. Black or orange for the rest of the pattern. **Tail:** Fairly thick bunch of light elk hair, flared.

**Rib:** Fine gold wire, or small oval gold tinsel.

**Body:** Antron fluorescent yellow. Either wrapped as a stand of antron or dubbed.

**Hackle:** Ginger or badger palmered over the body. Grizzly palmered over the dubbed thorax.


**Thorax:** Dubbed amber goat hair over the butts of the elk hair wings. **Head:** Orange thread head.

**Tying Instructions:** Attach and secure the thread at near the rear of the hook. Wrap the thread toward the eye dressing about 2/3 or the shank. Stack a clump of light elk hair and tie it in at the 2/3 position leaving enough to make a tail which should extend about one gape length beyond the barb.

Wrap the elk hair on top of the shank back to the tail position. At the tail take a tight wrap to make the tail flare. Tie in the gold wire rib and either dub or wrap yellow fluorescent antron to the 2/3 position where the tail was tied in. Tie in a badger of ginger hackle by the butt and make two wraps close together around the body then palmer the hackle to the tail position. Tie off the hackle with the gold wire as on the Elk Hair Caddis and spiral the gold wire to the front of the body. Wrap both the hackle and the wire clockwise. At the end of the body (2/3) up the shank, dress the hook shank and tie in a clump of stacked elk hair which will extend to the bend of the hook. If the elk has any curvature tie in the hair to have a convex wing .

Trim the butts of the elk hair to make a tapered thorax, (Larger at the rear) leaving sufficient room for a moderately large thread head. If your are not using orange thread, change over now and return the thread to the base of the wing. Tie in a grizzly hackle and dub a tapered thorax over the butt ends of the elk hair to the eye position. The thorax is tied with amber goat dubbing. (We will use rams wool). Wind three to five turns of grizzly hackle over the dubbed thorax and secure it at the eye. Hold the hackle fibers back and make a moderately large thread head. Cement.

The irony is that it was the smallest turnout in years with the largest number of fish caught, and it was only 200 yards, if that, from the launch Bill would not even have had a chance to ground his boat..
