From the CONSERVATION DESK

Last month I summarized the conservation goals of a number of organizations that you may want to support and said I'd give you more details later on. This month I'll highlight NCCFFF. I was elected to its board of directors a couple of months ago, so I'll be bringing you more on this organization in the coming months

The Northern California Council of the Federation of Fly Fishers (NCCFFF) represents over 30 clubs as well as non-affiliated individual members. NCCFFF is the only conservation group exclusively representing the interests of fly fishers in Northern California and Nevada. NCCFFF goes to bat for the places and the fish important to our members. You can find more information on them on the Internet at http://www.nccfff.org/. Here are a few highlights of recent NCCFFF conservation activities.

- Sponsored and cosponsored proposed sport fishing regulation changes to protect 12 fishing locations from over-harvest, including the Little Truckee River and the Merced River
- Participated in development of the Management Plan for the Upper Sacramento River, resulting in the designation of over 28 miles of the Upper Sac as Wild Trout and Catch and Release Water.
- Presented both written and oral testimony at CALFED hearings, outlining program deficiencies in protection and restoration of fish and fish habitat
- Submitted written and oral testimony on behalf of the angling community on the proposed divestiture of PG&E's hydropower facilities, including those on the Pit, Hat Creek, and McCloud Rivers.
- Participated in two lawsuits to force National Marine Fisheries Service to follow the recommendation of their own scientists and provide protection for dwindling steelhead populations.
- Submitted letters and testimony calling for increased flows for restoration of fish and fish habitat as part of the Trinity River Restoration Plan; mobilized fly fishers to submit hundreds of comment cards
- Cosponsored a legal challenge to the Department of Fish and Game to halt bad practices associated with issuance of special suction dredging permits in our rivers
- Took formal action in an effort to secure river flows necessary for healthy fisheries on multiple rivers including the Scott, Shasta, Calaveras, Feather, and Tuolumne rivers
- Participated as a stakeholder in monitoring a proposed dam replacement project on the

Truckee River which could divert water critical for healthy fish habitat

- The NCCFFF Striped Bass Committee has been monitoring CALFED restoration plans in the Delta and pushing for action to create a healthy, self-sustaining striped bass fishery.
- NCCFFF is representing fly fishers in the relicensing process for Pit River Power Houses 3, 4, and 5, which will determine the future condition of this important fishery.
- NCCFFF provides Email updates on conservation issues of interest to fly anglers. (To subscribe, send an Email message to rnferro@yahoo.com with "subscribe" in the subject line)
- NCCFFF is a supporter of the California Sportfishing Protection Alliance (CSPA).

Conservation News from NCCFFF

This alert requesting your letter in support of Martis Lake comes from Richard Anderson of Truckee.

Background:

The Placer County Board of Supervisors is preparing to approve the EIR for the Martis Valley Community Plan. The fly-fishing community has been successful at getting planning staff to include policies in the Martis Valley Community Plan that specifically state Placer County will protect Martis Lake's sport fishery as Martis Valley develops. However, these policies are merely the first step -- what's important are the programs that'll be used to implement them.

At this time, the Community Plan does not identify these programs, and the Environmental Impact Report presents a set of programs and mitigation measures that are inadequate to protect Martis Lake and its trout. The primary concern is that there's no overarching water-quality and fisheries-health monitoring program that assesses the cumulative impacts that would occur from valley-wide development. The only monitoring programs required in the EIR would be project-specific -- for, say, a particular golf course. But even if the impacts from this golf course were insignificant, when impacts from all projects are added together, the combined effect could be quite harmful to the fish.

Letters Needed:

Individual letters and letters from organizations are needed. Letters should be addressed to the Placer County Board of Supervisors, referencing the Martis Valley Community Plan Final EIR. Letters should make the following points:

- The Martis Valley Community Plan will allow the development of at least 6,000 additional homes, plus golf courses and commercial space, upstream of Martis Lake.
- 2) It is the responsibility of Placer County to

ensure that this development does not harm the lake and its highly-regarded trout sport fishery, which is an important recreational resource.

The County can't protect the lake if it doesn't know the severity and source of impacts caused by development. The Martis Valley Community Plan therefore needs to include a program that will adequately monitor water quality and fishery health in Martis Lake, with the objective of ensuring that neither are impaired. At the very least, this monitoring program must be designed to assess the cumulative effects of development across the valley.


Casting Tips

Wind knots caused by those irritating catches in your leader and line. What causes them? Simple physics explains that your line is going to travel completely through the plane. If we fail to let is completely unfurl and start the forward cast on a different plane, then the forward cast and the back cast will pass each other on the bends below the plane of the backcast, causing the tailing loop. How do you fix this?

The easiest fix is to learn to begin your forward cast with slow acceleration to the power stroke so the rod tip doesn't flex below the plane of the back cast. Remember smooth acceleration not squealing your tires. Don't be in a big hurry to start your forward cast. Let the back cast unfurl most of the way before beginning your smooth forward stroke. The longer your cast is the more you have to wait. Get out on the lawn and practice casting with the smoothest stroke you can accomplish.

Backcast....wait....slow smooth acceleration forward. It is like a ballet. Fluid and smooth. Good Luck. From Tippets, Tapers and Tales – Red Cedar Fly Fishers Tailing loops. Don Hull FFF Certified Casting Instructor

[Editor's notes: Your forward cast should be a smooth and gradual acceleration of power forward to a firm stop. Point: the stop. Tailing loops are primarily caused by too much power at the beginning of the forward power stroke, as well as to little arc for longer casts. So think about "powering" to the stop, like throwing a dart.. Also, lifting the rod or having a convex upward arc at the end of the cast, causes the loop to travel below the rod tip, and tails. Practicing both making and correcting tailing loops will help master this problem. FFCCI.]



CIRCLE HOOKS FOR FLY TYING? [excerpted from article on Circle Sculpin.]

When an angler first sees a circle hook they KNOW that you can't catch a fish with it. The point is bent in so much it points toward the shank. This must be a joke!! Actually, this design can be traced to the earliest days of fishing with bone and wooden hooks. As strange as it looks it hooks and holds fish.

According to Dr. Hook (Product Manager Geir Sivertzen, O.Mustad & Son A.S., Norway), "The more modern version of Circle hooks are known to be a result of 'product development' among commercial fishermen fishing the reefs of Australia early last century. They lost lots of hooks and lines due to their classic Mustad hooks hooking up the reef. By modifying the point, curling it in as much as possible, they experienced that less hooks were lost. In addition to this fact, they found that their catch ratio increased!!" (Then they had the new designs manufactured by Mustad.)

During the last two or three decades commercial long line fishermen adopted circle hooks for several reasons: * Increased hookups, up to 85 percent in some cases. * Just about all of the fish were hooked in the corner of the mouth. * Generally, the fish didn't get off. *Fish hook themselves. * Fish were easier to get off the hook once on board the boat. Observing this, sport saltwater anglers began experimenting with circle hooks, and their experience paralleled the commercial fishermen. When a fish swallows a bait the hook and bait will slide out of the gullet as the line is tightened and not catch on the gills or other sensitive parts. The hook catches on the corner of the mouth. Mortality was so much lower than with traditional J hooks that many saltwater tournaments and some states like California require circle hooks for bait fishing in saltwater.

Ok they work with bait, but can you tie a fly on them? The saltwater fly tiers found they could and the fishing experience paralleled that of the bait fishermen. Some care was needed to keep the gap free, and a common Complaint was that the shank wasn't long enough. Hook manufactures are coming out with longer shank hooks like the one Marvin Nolte used to tie this pattern. Now freshwater fly anglers are slowly checking out circle hooks. One thing to remember on selecting circle hooks is to pick ones with no offset. With too much offset you lose the advantage of a circle hook.

Eliminating the instant strike reaction is the biggest circle hook challenge for many fly anglers. We have to wait until the fish has turned away. That is when the hook will pull out of the throat, slide around the corner of the mouth and embed itself. The fish sets the hook; you don't need to. Recommendations include: Let the fish swim away before tightening the line. Continue with a regular strip speed. Line strike not rod strike. Hang on to the line as the fish pulls away. You will have to experiment.
