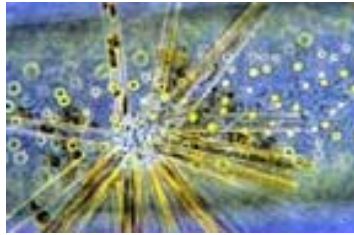

“Entomology for Fly Fishers”  
With Ken W. Davis



Ken Davis is an Aquatic Biologist, Wildlife Photojournalist, and Wildlife Historian. He has worked and recreated in waterways all his life. At his mother's frequent dissatisfaction, he spent most of his youth in Northern California's creeks fishing and catching frogs. Some things never change! He's still chasing tadpoles and bringing home bottles of pond water. Most of his projects involve water and invasive species. An important part of his work is doing aquatic surveys for a variety of microscopic species. The algae in the center photograph above were collected in an urban creek that is polluted with urban runoff. The star-shaped species is typical of water polluted with inorganic substances. As a kid, Ken would seek hellgrammites (right photo above) as they were guaranteed to catch trout. He's now hunting for these and other interesting invertebrates found in trout streams. ## **From the CONSERVATION DESK**

**Sacramento-San Joaquin Delta** The latest activity on the Delta is a couple of senate bills, SB-1612 and SB-1574. SB-1612, carried by Senator Simitian, would mandate the construction of a peripheral canal or pipe with an intake location downstream of Freeport. There's no language about size or fish protection and there's nothing that provides for protection of fish. This is a bill to oppose!

SB-1574, carried by Senator Kuehl, would mandate DWR and DFG to study reduced export pumping as an alternative in the South Delta Improvement Project (SDIP). Please let Senator Kuehl know you support SB-1574 and oppose SB-1612. You can find details of both bills at the Senate's web page <http://www.sen.ca.gov/>.

**Klamath River news** The Pacific Fishery Management Council voted earlier this month to allow a limited salmon season off the northern California coast. The decision was a result of projected record low numbers of returning salmon in the Klamath River this year combined with low numbers in each of the last two years. The Council recommends measures to the National Marine Fisheries Service so the decision isn't final. It would still cause a great deal of economic pain to the west coast fishing industry. The only real solution to the salmon situation is to repair the river so the salmon run remains vibrant. Learn about the Council at <http://www.pcouncil.org/>.

On the bright side, a federal judge ruled in late March that the Bush administration can not continue to strangle water flows in the Klamath River in years with average or below rainfall. The court sided with fishing and conservation groups that have been seeking a more balanced distribution of water needed to rebuild Klamath River salmon stocks. The court ordered the federal Bureau of Reclamation to provide river flows needed for Coho salmon now, instead of waiting for five more years to pass.

**Salmon Fisher (non) Disaster** Almost a year ago 37 members of Congress, two governors, and fishing groups pleaded with the NMFS to declare the 2005 salmon season a "fishery disaster" under the Magnuson-Stevens Fishery Conservation and Management Act. This would make salmon fishermen eligible for low interest loans to help them cope with the poor season last year. Despite pleas for a speedy decision, the NMFS decided early this April not to declare the 2005 season a disaster. This doesn't bode well for the fishing industry for this season, either.

**Smith River snagging** Snagging of salmon on the Smith River has become commonplace. The NCCFFF will shortly sent a letter to the State Fish and Game Commission requesting that the Commission take immediate "emergency" action to adopt a North Coast regulation change requiring immediate "in water release" of all salmon (Chinook, Coho, et al.) not retained as part of an anglers "take" limit. Apparently, many salmon have been taken just for the roe, and the carcasses have been discarded. Stay tuned for more on this issue. I'm sure it will continue for a while.

**Governor's appointments** The Governor is about to appoint 2 new members to the State Water Resources Control Board.

These are important policy positions that can affect river flows for many years. ## Sugar Creek Ranch

Like clockwork, Bobber and Donn Erickson drove in separate cars up my driveway at 5:30 AM, Saturday, April 8th. We were headed for the Sugar Creek Ranch "Seven Sacred Pools" for two nights of fishing with Bill & Diane Moy, Greg Bonovich, and his son Nicholas, and a guy named Phil from Redding. Our mission was to meet everyone at 8AM at the Black Bear Restaurant in Redding. Of course, this meant that we needed to stop by the Redding Fly Shop to drop our obligatory \$100 each before proceeding on to SRC. Before we left, John and Bobber got some excellent advice from Cary Boyden and John Daniels about what to use. Essentially, the advice was to use little Red Midges, Black and Gold and Black Midges in sizes 16-22, and an assortment of Wooley Buggers. All of these turned out at various times to be just the ticket.



In my "minds eye" I had imagined SRC to be some kind of "resort", obvious from the road and certainly containing some kind of "decorated" entrance. What we found was an ordinary gravel and dirt driveway entrance, with an ordinary green metal gate, and a small old wooden sign on a 4x4 that read "Lodge ->". From the road there are piles of river rock "tailings" from an old gold mine, but you cannot see any real body of water or ponds, and certainly there is nothing that screams "resort". The driveway entrance lead to a 2 story, "tri-level" because of the sunken living room, with an underneath built in two car garage and laundry. Strangely, you entered into the breakfast nook and kitchen as the "foyer", with a sunken living room to the right, a dining area to the left, a family room to the rear, 3 bedrooms, 2 baths upstairs and a half bath downstairs. Nevertheless, there was plenty of room for eight and the fully equipped kitchen only required that you bring food and beverage.



The fishing was superb, hot, terrific, and the fish were large, "monster", fat, heavy bows and browns. There is a "Norman" in one of the ponds that can snap, and did mine twice, any 5x leader away from the knots. There are plenty of pictures of "Norman" and he looks to be about three (3) feet long. Since we all had different experiences at different times, I had landed 7 large trout on Blood Midges Saturday night. Sunday, Midges of black, black and gold, red, size 16 to 22 could not even stir a fish. Donn had good luck on Saturday and Sunday catching nine in just a short span of time on Sunday. Bob Beverlin, the Bobber, caught plenty of fish throughout and was probably the best caster in our Club group.



The ponds are crystal clear, fed by springs and water that has been filtered through gravel and sand, and you can watch disinterested large trout circle any Midge offering you provided. But, put on an Olive Green Wooley Bugger, with a colorful blue tassel tail, strip it slow enough, and well, we have pictures. Bobber had gotten up with the Sun and Redding Phil on Sunday and had pounded some of the larger lakes, but I believe he was skunked for the morning. Nevertheless, we must have landed 20 large trout each (of the Club members) in a one full day and two half days and had at least half as many hookups.



Finally, Monday came too soon and was one of my finest days. With all of the lousy weather, cancelled trips, rushing rivers, this was the first time I had wet a fly in 2006. Despite a private "lesson" (i.e. 10 minutes) with Lefty Kreh, sessions with Mel Kreiger, lessons from Jeff Putnam, and countless winter readings, I casted like crap. Up to Monday, I managed to find every bush, tree, reed, I could not "load the rod", had casts that only went fifteen feet into the wind, and I cut up two brand new leaders after trying to unscramble them following feeble attempts at the Single and Double Hauls. Both Donn and Bobber reported their casting challenges with elevated lawns or those nasty thorny bushes. Somehow, like a golf swing, my casts finally came together on Monday, and after taking off the indicators and Midges, the Wooley Buggers were being eaten by really big trout.



SRC is not cheap, but if you want grassy lawn free cast zones, your own private pond or 2-3 acre lake, plenty of active large trout on the seven ponds, a comfortable "lodge" where all you have to bring is the wine, beer and food, then log into [www.sugarcreekranch.com](http://www.sugarcreekranch.com) and check out some of the "monster fish" others have caught.

Oh, and around Dunsmuir, where there is a sign that says 65 MPH, there is a CHP Officer sitting on the side of the road who loves writing tickets, make sure you are not locked in at 78 MPH, because he is bored and he does not care too much for fly fishers, nor for driver's licenses with CHP stickers on them. I could use some help with "on line three hour traffic school" recommendations.



I would say that the three members had an excellent, and memorable, time and that Sugar Creek Ranch is one of the only places you can find large active trout in clear pools in this rainy spring 2006. I already want to go back with my fellow Fly Fishers of Davis brothers and to paraphrase Paladin: Have rod, beer, wine and food, will travel. – **John Imsdahl**

### Lower Sacramento Outing

We went on the Club trip to the lower Sac on March 18. At The Fly Shop, Jim Wright and I met our guide Greg, who suggested we try the Trinity, as the Sac flows were pretty high (about 30,000 cfs) and winds were predicted to be nasty. An hour later we launched on the Trinity, complete with shuttle service, and rigged up with Greg's special bead—larger than usual—2" above a size 10 hook, then added a size 14 dropper 14 inches down. Flows were nice. I hooked a beautiful 18 inch Brown and both Jim and I got 2 hard-

fighting steelies boated in the 4-6.5 lb range—losing several more. We also caught about 20-30 half-pounders—nearly all fish on that crazy bead. I snapped Greg’s Sage in two on one hook-set and snapped off 2x fluorocarbon on the biggest dam fish I can imagine. Winds and weather were wonderful and we put in a fun, full day. - **Donn Erickson**

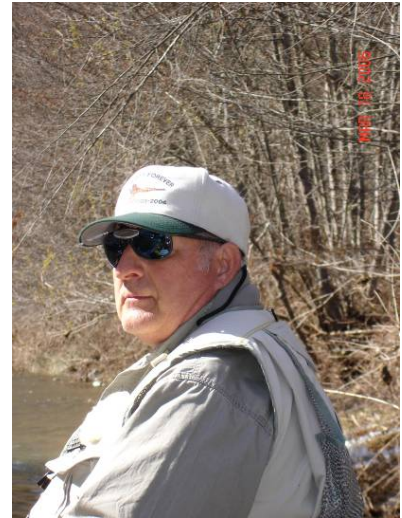

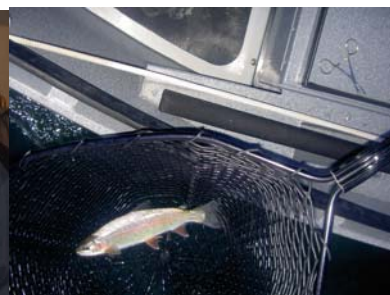

### Fly of the Month Dave's Bleeder - aka Wet Pinky



The fly of the month for April is a Shad Fly that has proven to be very effective on the American river. Al Smatsky discussed this fly in his excellent presentation last month. Al was gracious enough to send the following note about the fly and his tying instructions.

Given the water flow of recent times, the American may be one of the few places to shad fish this spring.

**Al's note and tying information:** This fly is quite simple to tie and the Number One shad fly on the American River. From personal experience it also works well on the Yuba River or any river with good visibility. The uniqueness of this fly is what sets it apart; it starts out white and turns pink when it gets wet.

This fly was introduced to me back in the late 80's on the American River by Dave Howard, an avid shad fisherman. If you have been around the scene for a number of years you realize that shad fishermen are not the most forthcoming when it comes to stream side information but that was not the case

with Dave. He always had time to help fellow anglers with mastering their casting and mending skills. Before he left the angler on their own, Dave would tie on one of his shad flies. Most of the time, within a few casts, the angler would hook up and guess what, it would be on Dave's fly.

#### Dressing

- Hook:** Size 6 or 8 1197 Nickel or Gold
- Thread:** Florescent Hot Orange Flat Waxed Nylon
- Tail:** White Marabou (original pattern)
- Under Body:** Florescent Orange Flat Waxed Nylon
- Body:** Fine or Medium White Chenille
- Rib:** Copper Wire (original pattern)
- Eyes:** Gold Barbell eyes – 1/8" & 3/16" for #8 or 6 respectively
- Note:** You can substitute variuos colors of Krystal for the tail

#### Tying Instructions

1. Pinch down the barb on the hook.
  2. Tie in the eyes slightly behind the hook eye.
  3. Wrap the thread back to the bend of the hook.
  4. Tie in a small amount of white marabou or 12 to 15 strands of Krystal flash. Tie in the copper wire and white chenille.
  5. Wrap the tread up to the eyes. Make sure you completely cover the hook shank with the thread. To make a fuller body, wrap the shank with more thread.
  6. Wrap the chenille to the eyes and tie off.
  7. Counter warp the copper wire to the eyes and tie off.
  8. Form the head of the fly with the thread.
- It doesn't get any simpler than this for tying an effective shad fly.
