

From the CONSERVATION DESK By Lowell Ashbaugh

Support Goose Creek and the Smith River! Western Rivers Conservancy, CalTrout and the Smith River Alliance need your help to protect the headwaters of California's finest salmon stream, the Smith River. The Smith's largest tributary, Goose Creek, is owned by Green Diamond Resource Company (formerly Simpson). Last cut in the early 1960s, the Goose Creek watershed is nearing a new cycle of harvesting. Western Rivers Conservancy has signed an agreement with Green Diamond to purchase all 9,483 acres of private land in the Goose Creek watershed, thereby safeguarding the entire watershed from logging and development.

Western Rivers Conservancy is working to secure federal funding for the U.S. Forest Service to purchase the land from us and incorporate it into the protected Smith River National Recreation Area (NRA). In this effort, they are working with California Trout, the Smith River Alliance, Green Diamond Resource Company, the Six Rivers National Forest and Del Norte County.

Your Voice Matters: Letters to Congress from concerned citizens like you make a large impact in supporting conservation efforts on the Smith River. Your support will help secure an appropriation from Congress to fund this project. Please help protect the future of California's finest wild river ecosystem and write the congressional delegation now. Salmon Season Decision The National Oceanic and Atmospheric Administration's Fisheries Service federal government adopted recommendations by the Pacific Fishery Management Council for deep cuts to the 2006 California and Oregon salmon season.

There are plenty of salmon in the sea, but most are Sacramento River fish. Because Klamath and Sacramento salmon mingle in the ocean, restrictions must be imposed when Klamath salmon fall to critical levels -- as they have in recent years.

NOAA officials said the 2006 season restrictions will allow 21,000 mature spawning salmon to return to the Klamath instead of the 25,000 fish that are expected. At least 35,000 returning salmon are considered essential for optimum fishery production. Klamath spawner returns have fallen below the 35,000 figure at least 13 times, and have rebounded in subsequent years.

Commercial fishing in California will be allowed in the Monterey region from Pigeon Point south in May. Beginning in June, commercial fishing will only be allowed south of Point Sur until July 26. It will be allowed north to Point Arena after July 26 but will be restricted to 75 fish per boat per week. A limited trolling season also will be allowed around Fort Bragg in September.

Recreational anglers face significant restrictions in the northernmost part of the state, but will be able to fish as usual out of San Francisco area ports.

<u>Salmon Legislation</u> In response to the salmon season decision, Congressman Mike Thompson introduced Salmon Disaster/Restoration legislation last month (HR 5213). Senator Barbara Boxer introduced a similar bill (S 2649) in the Senate.

This legislation will need broad public support if it is to be passed. I'll let you know to whom letters and other contacts should be directed.

Thompson's bill would do the following:

- **1. Emergency Appropriations <u>\$81 Million</u>:** Through the Department of Commerce, provide emergency appropriations to the Pacific States Marine Fisheries Commission to efficiently distribute the funds to the impacted commercial fishermen, tribes and related businesses in the region. This number was calculated by the states based upon a complete fishery closure.
- 2. Immediate Conservation Measures \$45 Million: The Department of Commerce would have 6 months to complete its recovery plan for the Klamath's Coho salmon (they were tasked to complete this plan in 2002, but have not finished it yet). After completion, the conservation funds would be distributed until expended to install and update: stream gauges and monitoring equipment, fish passage projects (i.e. road work/culverts, fish screens), riparian buffers, and add additional NOAA Fisheries staff and resources to better track and study the Klamath River's salmon in the ocean and rivers. Such projects are aimed at providing the "biggest bang for the buck." Counties and the states are working together to prioritize the projects and will get them to Commerce as they complete their Coho recovery plan.
- **3. Report on Conservation Projects**: For the first time, the Department of Commerce would be required to report back to Congress each year on how their conservation projects have increased water quantity, improved water quality, increased salmon populations and specifically benefited salmon spawning habitat.

Truck Fish or Build Ladders and Screens on Klamath?

PacifiCorp proposed to use a less expensive system of trucks and traps to haul salmon around dams on the Klamath River rather than spend \$200 million to build fish ladders and screen turbines -- at least until it sees whether the fish can survive in waters they haven't inhabited in nearly a century.

<u>Trinity Flows Highest in Decades</u> This year has been designated an "Extremely Wet" year for the Trinity River, allowing flows to be raised to their highest levels in years. Flows are currently at 4500 cfs, and are scheduled to go to 8500 cfs for six days by the time you read this.

The Westlands Water District, which receives Trinity River water to farm marginal land in the San Joaquin Valley objected to the designation with a letter to the Bureau of Reclamation threatening legal action. The Hoopa tribe countered with a letter recommending that the district's contract be set aside and not renewed unless it stops ignoring the 9th Circuit Court and agrees to abide by the court's decision.

Meanwhile, the Bureau of Reclamation raised river flows to make room in the lake behind Trinity Dam for expected snowmelt. The lake was perilously near the top. The flows should be down to about 450-500 cfs by the time of our Lewiston outing. Until then, be careful on the Trinity!

New Secretary of Interior? President Bush has nominated Idaho Governor Dirk Kempthorne to replace Gale Norton as Secretary of the Interior. The Senate is scheduled to begin confirmation hearings on May 4th. Kempthorne, a former Senator himself, will likely be confirmed, despite his abysmal record on the environment.

Throughout his career, Dirk Kempthorne has maintained close ties to timber, mining, and development corporations. Before running for public office, he worked as public affairs manager for the agricultural chemical company FMC Corp. and vice president of the Idaho Homebuilders Association. He was elected mayor of Boise in 1986, and served one term in the U.S. Senate from 1992 until 1998. He then retired to return home to Idaho, where he was elected Governor in 1998, and again in 2002. In his 2002 gubernatorial reelection campaign, Kempthorne received more money from timber, mining, and

energy industries than any other western gubernatorial candidate.

Perhaps not coincidentally, his League of Conservation Voters environmental voting record in the U.S. Senate was a dismal 1% for his six years in the Senate, and as governor of Idaho he has a dismal record on conservation of wildlife and habitat. Fly of the month Parachute Anything

This month is tiers choice. You can tie any fly as long as it is a parachute dry fly. Since we have covered a lot of standard flies over the last several years, it seems appropriate to let the tie decide on a pattern and show some versions we may not have seen previously. Consequently, you can let you imagination be your guide and submit a parachute fly of you choice. The accompanying information was assembled for a parachute Adams, but the techniques will work for any parachute. The technique for posting the wing and tying in the hackle is a method used by Skip Morris.


Thread: 6/0 or 8/0 **Hook:** Standard dry fly

Wing: post

Hackle: wound parachute style

Head: Thread head.


Tying Instructions: Starting at the wing position, lay in a thread foundation and tie in a clump of post material with the butts extending toward the rear of the hook. White calf, artic fox, antron, or other materials work. Secure the post material keeping the fibers on top of the hook and trim the butts at an angle sloping toward the rear. (Tie in any krystal flash or accent flash on top of the calf tail at this point)



Lift the calf tail and wrap in front of the wing to stand the post at a right angle to the shank) Starting at the base of the post wrap upward about 1/8 inch and down to the base. Strip about 1/4 inch of the stem and tie in the hackle feather (or feathers) so that the shinny side is facing up and pointed toward the front of the fly. Wrap up to the top of the first thread wraps on the wing post and back down to the base. Wrap the hackle around the wing post with the hackle fibers radiating at right angles to the post. Each wrap should be under the previous wrap. Hold the hackle fibers back and tie the hackle down near the eye. If you are mixing hackle as in the Adams, wrap the second hackle and secure it in the same manner. Tying off the hackle

will be easier if you wrap them counter clockwise so that your thread wraps tighten the hackle when they are bound. Vary the density of hackle to suit the water conditions you plan to fish. Sparsely hackled parachutes float well. Fill in the area between the post and the eye with a small amount of dubbing if necessary and construct a small thread head, whip finish and coat with head cement. Cut the wing to length if you are using synthetic materials. Viewed from underneath the shank should be covered with dubbing from the tail to the eye. A thickening at the thorax is suggestive of the larger thorax on mayflies.

Variations: Cree hackle can be substituted for mixed grizzly and brown in the Adams pattern. Any white hair or synthetic material can be used for the wing post. Arctic fox makes a nice wing post, since the butts are small and this allows for a body with a minimum bulk. A few (6-7) krystal flash or accent flash strands in the wing post will make the smaller sizes easier to see. You cal also make the entire post of krystal flash or similar material. A post of fluorescent yellow, pink or orange hair improves visibility.



Skip Morris demonstrated an alternative method for synthetic post material that does not have tapered ends that is illustrated above. Select a length of post material twice as long and half as thick as the finished post. Hold the material across the shank (as if it were a down wing on a spinner) and wrap it with a figure-eight loop. Rotate the material 180° so that the wing is parallel with the tying table and under the hook shank. Pull the wing upright around the shank and post it as described above. For smaller sizes, tying the fly on a 1–x short shank hook (Mustad 94838 -for example) provides a larger gape. Since parachute flies ride in the surface, you may prefer to tie these patterns on ring-eyed hooks so that the leader and fly are on the same plane at the water surface.

PAYNE IN THE RANCH OUTING

John Reynolds put together another of his famous Payne-in-the-Ranch outings. Eleven club members met at the Guinda post office and carpooled from there to the trail head. The weather was in the 70's with a slight breeze. It was perfect. We climbed the fence and made the short hike into Road Kill Café for a brief stop to plan our attack on the bass ponds and take some pictures.

It was quickly remedied by "Captain Rod" (Tom Burton), using the old stand-by-can't-be-without duct tape. Donn was able to continue fishing and was one of the high rods at the end of the day.

If you have never been on one of Commander Reynolds' Payne Ranch outings you are missing out on lots of fun. We did not keep count of the fish caught but a conservative estimate would be somewhere around 100 fish caught and released by 11 clubsters.

Everyone was able to get out with incident and the snake bite kit, shovel and bible were not needed on this trip. However, there was a close encounter with Mr. Buzztail. John Reynolds reports that a rattle snake took up residence in the shade of several backpacks at pond #1 and they had to take a late lunch. John will conduct another Payne Ranch outing this fall.
