# From the CONSERVATION DESK By Lowell Ashbaugh

Klamath Tribal leaders confront Buffet Members of California's three largest Indian Tribes and allies from commercial fishing and conservation groups demonstrated last month at the Berkshire Hathaway shareholder meeting, known as the Woodstock of Capitalism. The group is demanding the removal of four Klamath Dams owned by Berkshire subsidiary PacifiCorp. Two members of the coalition asked questions directly to Buffett and his partner Charles Munger before a crowd of 27,000 shareholders. In response the normally polished Buffett fumbled through papers to read a written response. Instead of taking responsibility for his company's actions, Buffett stated that regulators such as the Federal Energy Regulatory Commission would decide the issue. Buffett declined to acknowledge that the Tribes are seeking a negotiated settlement with the company as is common in dam relicensing proceedings. The Federal Energy Regulatory Commission and the California Energy Commission have reported that dam removal is cheaper than relicensing even if the energy lost is replaced by other carbon neutral energy sources.

In a separate action, American Indian and commercial fishing interests filed suit against Pacificorp alleging its operation of the dams warms water and accentuates toxic algae blooms, which have crushed the river's fisheries and pose a serious threat to public health.

Delta Pumping Permit Endangered The U.S. Fish and Wildlife Service, which is supposed to protect endangered species, ignored information that showed the Delta smelt population crashed to its lowest level before approving a plan to increase water pumping out of the Delta. By disregarding that information, the U.S. Fish and Wildlife Service allowed farms and cities across the state to take water that was needed to help prevent the fish from going extinct, environmentalists contend. As I reported last month, Judge Oliver Wanger ruled that the State Water Project is operating illegally because it lacks smelt and salmon permits required under the state's endangered species law.

Opponents of pumping appeared to gain ground with this latest charge in their attempt to overturn a critically important permit that allows massive water-delivery projects near Tracy to operate, even though the pumps kill endangered smelt. In a separate lawsuit, they also are challenging a permit to kill salmon.

Lawyers for state and federal water agencies contend the permit is valid and should be upheld. The state's plan to avert the shutdown is to get a determination from the state Department of Fish and Game that the federal endangered species permits are sufficient. But Fish and Game officials, who have said it will be difficult to endorse the federal permits because of widely acknowledged flaws, will have an even harder time if the federal permit is struck down.

<u>Pumping questioned</u> State water officials inquired four years ago about getting approval to kill imperiled fish at the massive water pumps near Tracy, according to internal government e-

mails obtained by the Contra Costa Times. The department, which insists it has the legal authority it needs, nevertheless was making inquiries about getting a state endorsement as early as 2003, indicating that officials knew there was a possibility they could run afoul of the California Endangered Species Act.

Truckee River Action Needed Trent Pridemore sent the

We felt that we considered all anglers, while accomplishing our goal of protecting large spawning fish. We simplified angling regulations for all from the town of Truckee to the Nevada State line.

Opposition has risen that wants to overturn these new regulations. Help us support this decision by California Fish and Game and the California Fish and Game Commission. Please download a copy of the Word Attachment letter supporting their decision. Snail or e-mail Mail as many copies as possible directly to The Commission. The hearings are the first week in June. Act Now. Forward this material as wide and far as possible to anglers who understand the need for protection. Take it to your clubs, show it to your friends. Stand up for what is right for the resource! Be a Power!

California Game Wardens Foundation I've reported before that the California Department of Fish and Game is suffering from a chronic shortage of wardens. The state now has fewer wardens than it had decades ago, even though the population of the state has grown dramatically. Two major reasons for this are low pay and dangerous working conditions. Fish stocking under review A Sacramento Superior Court Judge ordered the Department of Fish and Game to review the environmental effects of stocking rainbow trout in the state's lakes and rivers. The review may result in reducing or eliminating stocking in some waters, in particular those areas that have suffered population drops in sensitive native fish and amphibians. DFG has argued its fish stocking program is exempt from environmental review – this ruling counters that view.

   safeguards, and sustainable timber program using the
   existing road system.
- Participated in advertisement addressing charge that opponents to the Pebble Mine proposal in Alaska were Un-Alaskan and Un-American.
- Joined sign on letter submitted to members Congress urging the support of comprehensive legislation to fight the introduction and spread of aquatic invasive species.
- Joined sign on letter submitted to grassroots coalitions in Wyoming that protect the WY Range and work for

- responsible energy development.
- Submitted comments to the Bureau of Land Management on the Montana Statewide Oil and Gas Environmental Impact Statement and Amendment of the Powder River and Billing Resource Management Plans.

#### **Conservation Committee Activities:**

 Held Conservation Committee meeting April 12th to determine grant recipients. Reviewed two proposals and funds for "Trout in the Classroom" in California and "Hydrodynamics of trout and habitat study" in New York were recommended by the committee.

#### **Legal Affairs:**

Monday April 9<sup>th</sup> - The Ninth Circuit Court of Appeals rejected the Bush Administration's salmon plan for dam operations on the Columbia and Snake rivers. The appellate court upheld a lower court ruling that the plan was illegal because is filed to comply with the Endangered Species Act (ESA). This decision should compel the federal agencies to look at all recovery options – including removing dams. The Federation of Fly Fishers is a plaintiff in this case.

# Fly of the Month



The Pheasant Tail Soft Hackle # 14

**Soft Hackle** flies have been around for a long time and they continue to be a very effective fly, as a recent club outing to Baum Lake will testify. The soft hackle fly is tied to imitate insects changing from a larva or pupa to a winged adult. Most soft hackle patterns are easy to tie. Different hook weights will allow you to fish this fly deeper or in the surface film.

**Hook:** Heavy, standard or light wire in standard

lengths. Size 10-18.

Thread: To match body, black, brown or tan in this

case, 6/0 or 8/0.

Tail: none (optional few pheasant tail fibers)

**Body:** Pheasant tail fibers

Rib: copper wire

**Thorax:** Dark dubbing, or peacock herl.

Hackle: Partridge flank.

#### **Tying Instructions:**

Debarb the hook and start the thread near the tail position. Tie in a length of copper wire followed by pheasant tail fibers. Tie in the pheasant tail fibers by the tips. Wrap a body with the pheasant tail fibers about 2/3 the way up the shank. Rib the body by counter wrapping the wire in even segments up to the 2/3 point. At the 2/3 point, dub a thorax leaving sufficient room to tie in and wrap a hackle plus a thread head. The partridge hackle should be sparse. Striping one side of the feather will produce a sparser fly. Tie in the tip first and wind the hackle forward. Finish the head with half hitches or a whip finish and apply head cement.

A variation in color can be achieved by using dyed pheasant tail. Bleached pheasant tail results in a lighter colored body. Hen hackle is an alternative soft hackle. The hackle feather can be tied in by the tip and wound as described above or the hackle can be tied in by the stem base and wound by grasping the tip. Stroking the hackle fibers with the scissors to fold them back before wrapping will help control the fibers. Often, the fibers on packaged partridge or grouse hackle are too long for small flies. If you plan on tying smaller soft hackle flies, it

pays to invest in a whole neck. Alternatively, you can tie in and wind the hackle at about the half-way point of the shank. Pull the fibers forward over the eye tie and tie them down with a few wraps of thread. Be sure the fibers are distributed around the shank. Now, tie the fly as usual and fold the hackle back over the fly and tie it down as the last step. You could also apply the hackle as a beard and/ or distribute the fiber around the shank.

Version II –Plus ostrich thorax

Hook: Heavy, standard or light wire in standard

lengths. Size 10-18.

**Thread**: To match body, 6/0 or 8/0.

**Tail:** Pheasant tail fibers

Body: Pheasant tail fibers wrapped.

Rib: copper wire

Thorax: Ostrich herl over dubbed thorax

Hackle: Partridge or hen hackle



Version III – deep water version

**Hook:** Heavy wire in standard lengths. Size 10-18.

**Thread**: To match body, 6/0 or 8/0.

**Body:** Pheasant tail **Rib**: Copper wire

**Thorax:** glass or metal bead sized for the hook.

Hackle: Partridge or hen hackle

#### Whales Hog Media Attention while Smelt Perish

Two wayward whales in the Delta have dominated media attention over the past couple of weeks, while the fate of the Delta Smelt has been ignored by all, including state and federal agencies responsible for protecting them. The whales' journey is insignificant in the larger ecological sense, but the Smelt are a harbinger of the fate of the Delta. Virtually no media have paid any attention to the plight of the Delta while they've devoted pages and pages to the whales. This is simply inexcusable! I've lifted the following from Hank Shaw's blog at recordnet.com. - Lowell Ashbaugh

Water Wars: Adios, smelt

(From Hank Shaw's blog)

The state Department of Fish & Game just released their latest <u>Delta smelt survey</u> and the results are depressing: The scientists found the little fish in only six places (out of 36) and found no more than seven in any one place (actually they found no more than an average of 7.49 in three tries) To put this in perspective, the average results from the May test from 2000-2006 found smelt in 20 places for an average of 173 fish. This is a staggering, possibly fatal drop in population.

#### Here are the full results:

2000 - 23 places, highest reading 175.16

2001 - 18 places, 342.62

2002 - 17 places, 91.83

2003 - 24 places, 32.98

2004 - 15 places, 123.82

2005 - 26 places, 106.12

2006 - 21 places, 341.92

2007 - 6 places, 7.49

Why does this matter? Well, Delta smelt are viewed as the best indicator of the environmental health of the estuary as a whole. Population levels of striped bass and king salmon are also declining. But it's even bigger than that. Smelt populations are the subject of a lawsuit surrounding the gigantic water pumps outside Tracy that supply water from the Delta to 25 million Californians. The plaintiff argues that the smelt's near-extinction are the fault of these pumps, and indeed, their crash coincides with increased pumping. The state argues that the pumps are only one reason for the decline. Both are probably right, but to what extent remains to be seen.

Bottom line: This smelt survey is so scary it could spark emergency action, which could translate into less water for Southern California -- in a dry year.

# ----- Outings Report -----

Reflecting the cancellation of the Payne ranch and Pyramid trips, there are no new outings to discuss this month. Signups for the May meeting will again focus on the October Sac trip as June will be, practically speaking, the last time to register for that trip. Moving to intervening trips: for those who will go shad fishing, we will meet at the usual locale of the Big 5 lot and have dinner afterwards. Road 48 is the likely destination, depending on the results of pre-fishing earlier in the week. Members signing up will be contacted early in the week to confirm plans and attendance.

The Davis trip may actually be ok based on early reports and thus not require or suggest side trips to Frenchman. This should be the last year of Pike Lake (knock on wood), and in 2008 we hopefully will be back to spectacular explosions on the surface of hordes of trout chasing "swimmers," as damsel nymphs are called. And we are all reserved for Poison Oak Hollow (River Oaks Resort camping area for those who did not experience the reason for the nickname) starting Thursday, July 12 (not the 15<sup>th</sup> as once noted on the website). Signups are as usual strong for this trip, but there is plenty of space available for interested members. Usually this is the best combination of fishing and socializing we have with pot lucks both Thursday and Friday and a group dinner Saturday at the hotel. - Cary Boyden
